## NARRATIVE

OFFICER FAIRCLOTH RESPONDED TO 4407 WEST 12TH IN REFERENCE TO A BATTERY REPORT.

UPON ARRIVAL CONTACT WAS MADE WITH CHRISTIE HOGAN (V1) WHO STATED WHILE SITTING AT THE LOCATION SMOKING, CARMALITA (S1) APPROACHED HER AND BEGAN PHYSICALLY ATTACKING HER BEFORE RUNNING AWAY WITH HER CELL PHONE AND FEMININE PRODUCTS. HOGAN STATED CARMALITA IS A YEAR OR TWO OLDER THAN HER BUT DID NOT KNOW ANY ADDITIONAL INFORMATION.

HOGAN STATED SHE DID NOT HAVE ANYONE THAT IS CLOSE TO HER WITH A PHONE AND DID NOT KNOW HER HOME ADDRESS. HOGAN STATED SHE LIVED NEAR THE INTERSECTION OF 14TH AND PEYTON AND DESCRIBED THE HOUSE TO BE BROWN BRICK WITH A GARAGE. THE ONLY HOUSE IN THE IMMEDIATE AREA OF THE INTERSECTION FITING THAT DESCRIPTION IS 4405 WEST 14TH.

A BROADCAST WAS CONDUCTED FOR CARMALITA. A REPORT NUMBER WAS PROVIDED. MVR AND BWC WERE IN USE.

## NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A ROBBERY OF AN INDIVIDUAL CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MS. TIMBERLY WALICE WHO ADVISED VEHICLE 1 HAD BEEN FOLLOWING HER FROM CHARLES BUSSEY AVENUE TO ELM STREET. WALICE ADVISED A YOUNG BLACK MALE EXITED VEHICLE 1 ON ELM STREET AND ATTEMPTED TO STEAL HER PURSE. WALICE ADVISED THE UNKNOWN SUSPECT GRABBED THE PURSE AND PUSHED WALICE TO THE GROUND.

WALICE ADVISED THE PURSE BROKE FROM THE STRAPS AS SHE FELL. WALICE ADVISED THE SUSPECT RE-ENTERED VEHICLE 1 AND DROVE AWAY. WALICE DID NOT APPEAR TO BE INJURED AND REFUSED MEDICAL ATTENTION. OFFICERS MADE CONTACT WITH MS. LATANYA STEELE WHO WAS ON SCENE.

STEELE ADVISED SHE WAS ON ELM STREET AT A RELATIVE'S HOUSE AND WITNESSED THE ROBBERY. STEELE ADVISED SHE WITNESSED VEHICLE 1 STOP NEXT TO WALICE ON ELM STREET. STEELE ADVISED SHE WITNESSED THE UNKNOWN SUSPECT PUSHING WALICE AND STEALING HER PURSE. STEELE ADVISED SHE OBSERVED VEHICLE 1 DRIVING SOUTH ON ELM STREET AND TURNING EASTBOUND ON 26TH STREET.

OFFICERS MADE A BROADCAST IN REFRENCE TO VEHICLE 1 AND THE TWO SUSPECTS. AT APPROXIMATELY 1830 HOURS, OFFICERS FROM THE SOUTHWEST PATROL DIVISION CONDUCTED A TRAFFIC STOP ON THE SUSPECT VEHICLE. OFFICERS FROM THE SOUTHWEST DIVISION TRANSPORTED CAMERON KINGSBY, WHO WAS THE DRIVER OF THE SUSPECT VEHICLE TO THE 12TH STREET DETECTIVES' OFFICE FOR QUESTIONING. OFFICERS CONTACTED WALICE AND STEELE AND REQUESTED THEM TO ARRIVE AT THE 12TH STREET SUBSTATION FOR QUESTIONING IN RELATION TO THE INCIDENT.

DETECTIVES FROM THE MAJOR CRIMES DIVISION INTERVIEWED KINGSBY. KINGSBY ADVISED THE VEHICLE WAS HIS MOTHERS. DETECTIVES FROM THE MAJOR CRIMES DIVISION QUESTIONED WALICE AND STEELE IN SEPARATE ROOMS. DETECTIVES FROM MAJOR CRIMES INFORMED OFFICERS THEY DID NOT BELIEVE KINGSBY TO BE THE SUSPECT.

DETECTIVES FROM THE MAJOR CRIMES DIVISION PROVIDED WALICE WITH AN INCIDENT CARD AND ADVISED HER TO CONTACT POLICE IF ANY FURTHER CONTACT WAS NECESSARY. WALICE AND STEELE LEFT THE 12TH STREET SUBSTATION. OFFICERS LEFT THE SCENE. BODY WORN CAMERA AND MOTOR VEHICLE RECORDING IN USE.

OFFICERS WERE PROVIDED WITH THE HANDLES OF WALICE'S PURSE WHICH WAS DAMAGED IN THE ROBBERY. OFFICERS TRANSPORTED THE HANDLES TO BE STORED AT THE 12TH STREET SUBSTATION AS EVIDENCE.
