NARRATIVE

OFFICERS RESPONDED TO A ROBBERY IN PROGRESS AT 19426 CANTRELL ROAD. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE MANAGER, WALIA, WHO ADVISED THAT A FORMER EMPLOYEE, SALAAM, HAD JUST ROBBERED THE STORE AND WAS STILL INSIDE THE BUSINESS.

OFFICERS TOOK SALAAM INTO CUSTODY WITHOUT INCIDENT. DURING THE DETENTION, SALAAM STATED HE WAS IN POSSESSION OF NARCOTICS. OFFICERS SUBSEQUENTLY LOCATED THE LISTED NARCOTICS ON HIS PERSON, ALONG WITH THE STORES TIP JAR CONTAINING THE LISTED CURRENCY. SALAAM WAS THEN ESCORTED TO THE REAR OF A PATROL VEHICLE. INITIALLY SALAAM ALSO REFUSED TO IDENTIFY HIMSELF TO OFFICERS.

OFFICERS MADE CONTACT WITH EMPLOYEES ON SCENE, KARN AND SINRANJIT. KARN STATED SALAAM HAD PREVIOUSLY BEEN FIRED FROM THE LOCATION AND ARRIVED PRIOR TO POLICE ARRIVAL, STATING HE WAS OWED MONEY. KARN ADVISED HE TOLD SALAAM HE NEEDED TO LEAVE, AT WHICH POINT SALAAM BECAME IRATE AND BEGAN CAUSING A DISTURBANCE. KARN STATED SALAAM THEN ATTEMPTED TO RETRIEVE MONEY FROM THE CASH REGISTER. KARN AND SINRANJIT ATTEMPTED TO STOP SALAAM, AND DURING THIS TIME, SALAAM PUNCHED SINRANJIT IN THE FACE AND TOOK THE TIP JAR.

SINRANJIT PROVIDED A SIMILAR STATEMENT AND WAS OFFERED MEDICAL ATTENTION, WHICH HE DECLINED.

OFFICERS ADVISED SALAAM OF HIS MIRANDA RIGHTS AND SPOKE WITH HIM. SALAAM STATED HE BELIEVED HE WAS OWED MONEY AND ATTEMPTED TO RETRIEVE MONEY FROM THE REGISTER. SALAAM STATED THAT WHEN KARN AND SINRANJIT ATTEMPTED TO STOP HIM, HE PUNCHED SINRANJIT IN THE FACE AND A PHYSICAL ALTERCATION OCCURRED. SALAAM ADMITTED TO TAKING THE TIP JAR CONTAINING THE LISTED CURRENCY AND PLACING IT INTO HIS POCKET.

WALIA STATED HE WISHED FOR SALAAM TO BE BANNED FROM ALL MARCOS PIZZA LOCATIONS IN CENTRAL ARKANSAS. OFFICERS ADVISED SALAAM THAT HE WAS BANNED FROM THE LOCATIONS AND THAT HE WOULD BE ARRESTED FOR CRIMINAL TRESPASS IF HE RETURNED.

OFFICERS CONTACTED MAJOR CRIMES DETECTIVES, AND SALAAM WAS TRANSPORTED TO THE MAJOR CRIMES DIVISION. ONCE THE INVESTIGATION WAS COMPLETE, SALAAM WAS TRANSPORTED TO THE PULASKI COUNTY REGIONAL JAIL.

SALAAM WAS CHARGED WITH ROBBERY, THEFT OF PROPERTY, POSSESSION OF A SCHEDULE VI CONTROLLED SUBSTANCE, ASSAULT IN THE THIRD DEGREE, AND OBSTRUCTION OF GOVERNMENTAL OPERATIONS. THE LISTED NARCOTICS WERE STORED AT THE 12TH STREET SUBSTATION, AND THE TIP JAR WITH THE CURRENCY WAS RETURNED TO THE BUSINESS. BWC IN USE.
